

Subject: BCY 21 Child Care Local Match Agreements
Date: March 9, 2021 Commission Meeting
Issue: Acceptance of BCY 21 Child Care Local Match Agreements from Boards
Facts:

Annually, local workforce development boards submit local match pledges to secure federal child care funds pursuant to Commission rule §809.17. This will be a standing agenda item, as Boards may continue to submit match agreements through January 31, 2021.

Staff requests Commission acceptance of child care pledges for donations, transfers, and certifications of expense for BCY 21 in the amount of \$6,645,028.

Today's summary includes eighteen (18) match agreements from ten (10) Boards which includes Borderplex, Cameron County, Capital Area, Concho Valley, Dallas County, Heart of Texas, Lower Rio Grande Valley, Northeast, Southeast, and Texoma.

All Boards have secured a portion of match, with all Boards securing at least fifty percent (50%) of their total match. Of the twenty-eight (28) Boards, twenty-six (26) have secured their local match target, and eleven (11) have exceeded their BCY21 match target.

Boards have secured 102.67% of the statewide child care local match target compared to 108.92% at this time last year (02/25/2020).

Two (2) Boards still have match agreements to provide TWC. Each of the Boards is currently working with their provider partners to secure their agreements.

Due to a longstanding partner not participating this year for Cameron County, the Board was able to secure pledges from two (2) new pledge partners: City of Harlingen and County of Cameron. Due to the new partners, Cameron County was able to secure their local match target for BCY21.
