 - Karen Stanfill will be leading quarterly RCT education and training.
 - Britni Miles, President of TX APSE will present in May.
 - RCT Member Mentorship program
 - Outline pending review from RCT Chair.
- Policy, Procedure & Personnel Development, Karen Stanfill, Chair
 - o Comprehensive System of Personnel Development
 - There were more counselors hired than terminated. The committee would like to track how many of these are retirement.
 - Question as to what the average length of time is a caseload was vacant before a new counselor was hired. The answer was an average of three months.
 - 204 counselors that have not taken steps in getting their masters.

- Looking for major changes to the substance abuse policy with updates how a person who has substance abuse will receive services.

- Training questions are being held until the trainer position at TWC VR is filled.

- CAP, Karen Stanfill
 - CAP served 255 clients
 - o Clients served with physical disabilities are down this year.
 - Legal clinics are being held for persons with disabilities that want to speak to an attorney regarding questions on college accommodations, social security, or guardianship.
- CRP, Bobbie Hodges
 - TWC VR held the 3rd Zoom quarterly meeting with over 200 providers attending
 - We identified regional Reps as facilitator that will help accomplish our goals to provider concerns within their region.
 - During the Zoom meetings the top 3-4 concerns provided will be discussed.
 - Mrs. Hodges provided some of the previous concerns that have been discussed during these meetings.
 - Concerns from providers not getting responses from emails and phone calls. This includes VR Standards email and counselors.
 - Jason Vaden is looking into these concerns.
- PRN, Lisa Cowart
 - PRN has four centers in the state of Texas with Partners Resource Network as the umbrella for 34 years. The grants are five-year grants have been awarded.
 - New multistate grant. Texas is one of the 6 states involved.

 - o Fifth transportation summit was held in January 2020
 - One of the many policy recommendations is to allow Texas Centers for Independent Living and other nonresidential facilities to obtain accessible parking placards.
